Activities of the Curriculum Committee are reported regularly to members of the Faculty Council through the distribution of the minutes of each meeting. Activities during the past year have included changes in all-university requirements (English proficiency), the addition of new majors, concentrations, and options, changes in catalog copy, and changes in specific courses and curriculum requirements. A summary of changes from March I, 1970, to February 28, 1971 is appended. A detailed analysis of specific curricular changes has been forward to each college and to each department. In interpreting the tabulations shown on the appended summary, it should be noted that the numbers of courses, credits and quarters per year are shown, but the numbers of sections per course or numbers of student credithours associated with each course are not.

Issues currently being considered by the committee include the following:

- Definitions of such terms as "major", "option", and "concentration" for use in catalog preparation.
- Procedures followed by departments for submitting curricular changes.
- Relationship between University goals and priorities to curricular changes.
- Relationship of financial considerations involving curricular proposals and actions of the University Curriculum Committee.
- Appropriateness of a major curriculum review by all departments to assess the need for specific courses and requirements, correctness of level of numbering of courses, and the economic efficiency of current course scheduling.
- 6. Methods of reporting curricular changes.
- 7. Procedures for streamlining the activities of the committee.
