The University Curriculum Committee reported its actions periodically through the minutes approved by the Faculty Council. In addition to the usual curricular items in the form of course and program proposals, the Committee

1. Transmitted to the Faculty Council as Special Action Items:
 - ✓ a. Disestablishment of the Department of Administrative Office Management and Business Teacher Education.
 - ✓ b. Joint administration of the Department of Food Science and Human Nutrition by the Colleges of Agricultural Sciences and Human Resource Sciences.
 - ✓ c. Establishment of a Department of Agricultural and Natural Resource Economics in the College of Agricultural Sciences.
 - ✓ d. Establishment of a Department of Plant Pathology and Weed Science in the College of Agricultural Sciences.
 - ✓ e. Establishment of a Department of Music, Theatre, and Dance in the College of Arts, Humanities, and Social Sciences.
- ✓ 2. Transmitted a subcommittee recommendation to award credit in transfer for approved work completed under the sponsorship of noncollegiate institutions (accredited in-house training courses).
3. Established subcommittees and charged them to study the following issues and to present recommendations at the appropriate time:
 - ✓ a. Course duplication among the several Departments.
 - ✓ b. Definitions of and practices regarding internship, practicum, and group study courses.
 - ✓ c. Certification and accreditation requirements imposed by external agencies and the impact upon curricula.
 - ✓ d. Course prerequisites and their relation to programs of study.
4. Evaluated the charge of the Committee and concluded no change is needed.
5. Reviewed the policies on repeating courses and the definition of the minimum grade point average required for graduation. The study continues.
6. Maintained contact with the committee charged to develop a proposal for revised graduation requirements.

Activities of the University Curriculum Committee were reported regularly to the members of the Faculty Council through the distribution of minutes of each committee meeting. In addition to the regular curriculum items regarding courses and program proposals, the following activities were carried out by the Committee.

Transmitted to Faculty Council as special action items:

Disestablishment of Department of Administrative Office Management and Business Teacher Education.

Joint administration of the Department of Food Science and Human Nutrition by the College of Agricultural Sciences and College of Human Resource Sciences.

Establishment of a new Department of Agricultural and Natural Resources Economics in the College of Agricultural Sciences.

Establishment of a new Department of Plant Pathology and Weed Science in the College of Agricultural Sciences.

Changing the name of the Department of Music to the Department of Music, Theatre, and Dance.

Established a subcommittee to study awarding of transfer credit for academic course work completed under the sponsorship of noncollegiate institutions. A proposal for awarding such credit was forwarded to the Faculty Council for deliberation.

Established the process to study course duplication on campus. Study currently in progress.

Studied a proposal to revise policies concerning repeating a course and the minimum cumulative grade point average for graduation.

Established a subcommittee to study certification and accreditation procedures for academic programs. A survey is being conducted to determine the impact of external agencies on curriculum requirements at CSU.

Reviewed a proposal regarding course prerequisites and their impact on programs of study.

Conducted a two-year follow-up study of the mathematics module program.
