The University Curriculum Committee (UCC) reported its actions periodically through the minutes approved by the Faculty Council. In addition to the usual curricular items in the form of course and program proposals, the Committee:

**1) Transmitted to the Faculty Council as special action items:**

- a) Request for major change to "Colorado State University Academic Core Curriculum-Report on Objectives and Criteria" to reflect changes made to the AUCC by UCC and Faculty Council in Spring Semester 2004.
- b) Request to change the name of the major in consumer and family studies to family and consumer sciences.
- c) Request to change the name of the Department of Chemical Engineering to Department of Chemical and Biological Engineering.
- d) Request to change catalog copy and minimum grade requirement for the undergraduate program in social work.
- e) Request to add a new B.S. program in biomedical sciences in the Department of Biomedical Sciences.
- f) Request to change name of M.S. in manufacturing technology and construction management to construction management.
- g) Request to change catalog copy regarding minimum grade point average in the major in biochemistry.
- h) Request to change the minimum grade requirement for undergraduate chemistry majors.
- i) Request to delete review course statements for the science concentration in the major in animal science and the science concentration in the major in equine science.
- j) Request to change minimum grade requirement for the major in economics.
- k) Request to establish a mathematics graduate interdisciplinary studies program.
- l) Request to establish a "Track 2, Disciplinary Honors Scholar," in the University Honors Program.
- m) Request to change minimum grade requirement for the major in sociology.
- n) Request to change catalog copy for the College of Agricultural Sciences.
- o) Request to change names of M.S. and Ph.D. programs in recreation resources to human dimensions of natural resources.
- p) Request to add Plan C Masters of Fishery and Wildlife Biology in the Department of Fishery and Wildlife Biology.
- q) Requests to change the minimum grade requirements for the English major and English minor.
- r) Request to add minimum grade requirements for the dance concentration in the performing arts major.

  - n) Request to change grading option for reserve-number courses in biochemistry from instructor option to pass-fail only.
  - o) Request to change minimum number of credits for master of music (M.M.) from 33 credits to 30 credits.
  - p) Request to add computing technology education concentration to major in computing technology.
  - q) Request to substitute M CC 117 and M CC 118 for M CC 120A-B and M CC 121, respectively, in current programs of study without requiring action by each department.
  - r) Request to change grading option for BICC 102 from pass/fail to traditional.
- 3) Processed a total of 584 new, major change, minor change, nontraditional, and drop course requests. (through April 8, 2005)**
- 4) Approved additions of or changes (major and minor) to 130 programs of study. (through April 8, 2005)**
- 5) Reviewed list of courses that had not been offered for 3 years (6 years in the case of alternate year offerings) and, following recommendations from department heads/chairs, either dropped or retained the courses.**
- 6) Approved for inclusion in the All-University Core Curriculum: 5 courses in category 3, 17 courses in category 4.**
