## 1) Transmitted to the Faculty Council as special action items:

- a) Transfer the minor in environmental engineering from the College of Engineering to the Department of Civil Engineering.
- b) Change the name of the Department of Civil Engineering to Civil and Environmental Engineering.
- c) Change the name of the Department of Fishery and Wildlife Biology to Department of Fish, Wildlife, and Conservation Biology.
- d) Add minimum grade requirement for the ethnic studies concentration in the liberal arts major.
- e) Add an organic agriculture interdisciplinary studies program.
- f) Add a merchandising graduate interdisciplinary studies program.
- g) Add a minimum grade requirement for the ethnic studies minor.
- h) Add a minimum grade requirement in mathematics for the apparel and merchandising major.subsequently withdrawn by department.
- i) Request for major change to "Colorado State University Academic Core Curriculum" to reflect changes made to the AUCC by UCC.
- j) Add a major in Fire and Emergency Services Administration.
- k) Add a Plan C Master of Accountancy (M.Acc.).
- 1) Add a Plan C Master of Management Practice (M.M.P.).
- m) Add a minimum grade requirement for history majors.
- n) Requests to change the names of the M.S. and Ph.D. programs in entomology and plant pathology and weed science to M.S. and Ph.D. in bioagricultural sciences.
